**Dennis Hood Quarter Horses will be referred to as **Breeder**. This service is engaged subject to the following:**

1. A **Booking Fee of \$300** from the above breeding fee is payable with this contract, and the balance of \$ \_\_\_\_\_ plus all other fees will be **paid at least 5 days in advance of shipment of semen.**
2. A **photocopy** of the registration papers shall be sent to the Breeder with this contract.
3. The breeding season for 2012 is from **February 1 to June 15.**
4. **Breeding/Collection days will be Monday, Wednesday, & Friday.**
5. Semen will be shipped on collection days only on an "available basis".
6. **Breeder should be notified no later than 8:00 AM Central time on the date the semen is to be shipped. Preferably 24 hours in advance.**
7. **Live foal guarantee:** Live foal means the foal shall stand and nurse and live 24 hours. Breeder must be notified within 7 days if there is no live foal.
8. **Genetic Diseases:** The Breeder shall be held harmless of any horse with genetic diseases (HYPP). If the above said mare has an H/H foal, the Mare Owner shall have the option of returning the double positive foal to the Breeder in return for a rebreed the following year.
9. A **breeder's certificate** will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of foal.
10. **Warranty:** Breeder is not responsible for lost, delayed, or damaged semen.
11. **Shipping Charges:**
  - a. **First Shipment---**free within U.S. (lower 48 states). If other shipments: charges will be **\$150** per shipment.
  - b. Breedings bought in Futurities will be charged **\$250** for shipping.
  - c. Shipment will be by Overnight Federal Express or UPS---**No counter to counter shipments available.**
  - d. Cooled Semen will be shipped in disposable containers and do not have to be returned.
12. This contract shall be null and void with booking fee refunded if stallion dies or becomes unfit for service.

This contract is not valid unless completed in full. When Mare Owner signs and returns the contract with booking fee the Breeder will sign and return a copy to the Mare Owner/Agent. Mail contact to the above address.
